[On 9/2/17 I was working as a Seattle Police Officer as unit 2-David-3. I was wearing a full Seattle Police uniform and driving a marked patrol vehicle.

I was dispatched to the report of a violation of a parenting plan. The mother's reports to me seemed to be different from papers and legal standings, as well as other reports. The mother, Tess Fauver (listed under different last name in SPD records) reported to me the following:

She stated that she has sole custody of her child, Krystin. This May, Tess reported that Krystin moved to Alaska with her biological father and has not

been heard from since July 7. Tess then stated that the biological father has sole custody, but that she was not made aware of that.

Tess feels that Krystin did not leave willingly, and that she is being held against her will there and not allowed to communicate with anyone.

Tess is upset that the father will not speak with her, and believes that she should have custody and visitation rights.

She stated that she is living on Pacific Highway in Des Moines rent-free, not working, and was at the Seattle address today to see a friend.

Tess referred to Krysten as her daughter and with female pronouns during our meeting.

Further investigation showed that earlier this year, in about May, CPS requested SPD to respond to check the welfare of Krysten. Krysten had run away from home and CPS had found that they found that tess neglected and was a heavy alcohol user. They also stated that Krysten now identifies as a male, and that Krysten's living conditions had been investigated by CPS.

I was not able to contact Krysten to determine their current gender identity or if they are using a different name.

Tess asked that I complete a report about what she had relayed to me, noting that there had been previous DV between her and the biological father who now has full custody.]
