Hi Teressa,

Thank you for connecting with Detective Castro as you're able, and please continue to reach out to anyone you feel comfortable with for support. I wanted to let you know that your case was sent to Detective Castro for more information, meaning the prosecutor was wanting more details or more evidence in certain areas. I don't have the specifics of what the prosecutor was looking for, but we can find out if you're interested. I think it's important that you know it has not been formally declined/dismissed yet. I can also stay in contact with the detective to understand the timeline for when they're able to provide the requested information to the prosecutor. Sometimes we see cases take a while to be sent back to the prosecutor, and others will only take a few weeks. I'm so glad that you shared with the detective how you feel about this case, it's powerful what you have shared and I hope you continue to share your perspective because it's so important. When you have an opportunity, feel free to email me back and we can talk about what you would like to see happen with the case.

The prosecutor has requested to have a joint interview with you, which would also include the detective and myself. During this interview, the prosecutor will be asking questions about the crime that was reported in order for her to clarify the information – and sometimes it's just helpful to meet someone and hear their story versus reading it in a report; as there are a lot of things that might be left out just by the nature of the reporting process. Generally, these interviews are recorded, but you can decide whether that's okay with you. These interviews can sometimes take an hour or more to complete and often take place at the prosecutor's office, in this case that would be the Regional Justice Center in Kent. I'm happy to answer any questions you might have and also talk about a date and time that would work for you.

I hope you are well and that we can talk soon.

Hi Heather:

Thank you for the email. I still don't have anywhere to live and have been staying with another unpredictable exboyfriend because I have nowhere else to go. In the past few weeks I had my purse stolen from me, which contained the last of anything my daughter and I ever owned prior to meeting Mr. Walag, as well as my debit card which was used to take the entirety of what little I had in the bank, my drivers license, my military ID, any other cards with my name on them, my keys, and of course my cell phone. I haven't had the money to replace my phone and due to Mr. Walag's actions, all of my original identifying documents have been taken from me and destroyed and I don't have a way to get new ones, one of the complications being that I don't have a mailing address. I was able to obtain a place to receive mail at, however, I cannot pick up mail without identification. On top of all this, I am still suffering the loss of my best friend, which happened about 3-4 weeks ago, and am trying to keep from losing my mind because at the very root of all this is me still trying to save my daughter from a devastating and incredibly bizarre custodial interference situation which has left her stranded in Fairbanks Alaska and unable to contact anyone, not even persons related to her on her biological father's side of the family. I apologize for losing touch. I'm at the library in Northgate right now on a borrowed laptop. Because of Mr. Walag, I no longer have any computers. I have not been able to get a new phone yet. Last week I actively sought one out, but many of the places giving free phones were experiencing their own complications. Maybe this week if I can get bus money and information I will be able to find a phone. I don't know who my advocate is. I don't have a way to call her, but I can email her the next time that I am able to use a computer that has internet access. I do not want this case to close and I think it would be a terrible reason to close it because my life has been complicated by Mr. Walag and his conduct. Thank you.

Before deciding to stay at Silver Shadow while you were in CA (and I almost didn't stay, but felt it foolish not to), I frequently indicated my hesitation at the situation due to my inability to

reimburse you at any future time for any expenses that could potentially arise. It seemed to me that you insisted I stay, as well as insisted on sending me money, despite my almost unwavering resistance to the point where saying "thank you" felt forced, because I felt pressured into accepting a lot of what you insisted on giving me, from money to loaves of bread i didnt ask for.

Ive made it a point to not ask you for anything. I know that your reasoning as you present it was to be helpful and nice, but my objections were Always because i felt you expected something in return, and, just as i told you before I came to stay in July, i have nothing i can repay you with and dont know when i can.

I am still finishing my legal documents needed to help my kid. I can show you my drafts and where i am right now. I am working my ass off almost all the time. I dont get monetarily reimbursed for this work. I am incredibly stressed out. I dont know why you are arbitrarily declaring i owe you money and threatening to kill my pets. You know I'm not receiving income. If you insist, i will happily set up a payment plan with you for when i am once again employable, even though we never spoke of such an arrangement in the past. I dont eat your food. I try to not get in the way. I think im relatively quiet. Im sure you gamble more than \$250/week just on scratch tickets. So money can't be the issue.

You have physically, emotionally, and verbally acted outside of our agreement of you "helping" me, as well as outside of my comfort zone, and outside of legal parameters. This is why I have felt more and more uncomfortable and have withdrawn from interactions with you. Any further threats or physical advances will be addressed and handled accordingly. You are suddenly saying I'm taking advantage of you when im only doing what was agreed on originally, and you have failed to maintain your end by keeping self control, making your true intentions behind all of this quite obvious.

You have crossed the line many times and it stops now. Ive been recording the frequent negative encounters I've experienced with you, from you forcing me to hug you and telling me to never pull away again, to other incidences. Please stay out of my area and dont go near my birds. Please do not threaten them or myself or declare any new terms to our original agreement, particularly ones you know i am currently unable to meet. Please do not touch me or them. Please stop trying to lock me out (?). This is my current home and i should be able to come and go as needed without fear.

I have contacted people about other places to stay. I need to finish my work before i can truly focus on anything else. I will be done soon/ASAP and i will make arrangements to vacate as soon as possible thereafter. If i have been doing something that bothers you, please let me know. I will stay out of your way as much as humanly possible. Please give me some breathing room because i am afraid of you but have nowhere else to live at this time. I am very consumed with the situation of my only daughter stranded in peril. Thank you for your respectful understanding. If you would like to talk, please keep it diplomatic and reasonable.
